## **Capacity Building Programme for Advocates preparing for Higher Judicial Services in collaboration with MPSJA**

With an object to enable advocates to compete in the examination of Higher Judicial Services, a collaborative initiative is being taken under the aegis of MP SLA & MPSJA. The Program is a meticulously designed capacity building initiative aimed at preparing advocates for the rigorous challenges of higher judicial services examinations especially for Advocates belonging to SC/ST, Minorities, Women, EOW & Others. This program focuses on enhancing participants' legal acumen, and critical thinking, thereby facilitating their successful transition to esteemed High Judicial Services position.

The programme offers a structured curriculum that covers a wide spectrum of subjects relevant to higher judicial services examinations. Special emphasis has been given to certain topics which are asked frequently in the previous years examinations.

**Note:-** 1) *The sessions on scheduled topics will be managed by M.P. State Judicial Academy's legal experts viz. Professors, Judicial Officers, Advocates etc.*

2) *The participants' legal problem which they want to be addressed shall be considered by the team of legal experts.*

### **The procedure to be followed in this programme :-**

- The abovementioned sessions will be covered through online classes. The classes will be regularly started from 24.08.2023, every week on Thursday, Friday and Saturday between 06:00 pm to 09:00 pm. No fee shall be chargeable from any candidate participating in this programme.
- The interested candidates may submit his/her application in Google form within stipulated time, if they are fulfilling the eligibility criteria for appearing in the Higher Judicial Examination as fixed by competent authority.
- Link of the Google form will be shared on website of MPSSA & MPSJA. The Google form shall contain necessary information related with applicant viz. Name, Father's Name, Age, Bar Enrollment No., Experience at Bar, Mob. Number, Email etc.

**Note:-** *The Bar Identity Card shall be mandatorily submitted with Google form.*

- The submitted forms shall be scrutinized in respect of whether the applicant is eligible to appear in the Higher Judicial Examination which is conducted by Hon'ble High Court of M.P.
- A Whats App/Telegram Group will be created and all the eligible candidates shall be added in the said group.
- The details of sessions to be held viz. Subject, Link, Timings & Date shall be communicated through Whats App/Telegram Group one week prior, but preferably they will be organized after court working hours.
- The programme will be hosted via WebX or any other suitable online platform on the basis of number of candidate participating in the programme.
- Preference will be given to Advocates belonging to SC/ST, Minorities, Women, EOW etc.

**The participant Advocates are directed to observe the following instructions:**

- The participants shall apprise themselves with the schedule of the Session communicated by MPSSLSA & MPSJA and to strictly follow the same.
- The participants shall apprise themselves about the use of WebX platform.
- The participants shall provide only their gmail id (in use) for accessing the WebX link provided by MPSSLSA immediately on email of the Authority [mpssajab@nic.in](mailto:mpssajab@nic.in)
